Deuteronomy 21:20 and Proverbs 23:21 explain that people who overindulge will come to poverty, while Proverbs 7:11 and Ephesians 4:28 tell us that people with a gluttonous heart are often associated with sin. The Seven Deadly Sins are not mentioned in the Bible but some sins are listed in Proverbs. Galatians 5:19-21 lists many other sins as well, including idolatry, hatred, and envy. The list of sins is often used to explain why people who commit these acts will not enter heaven. In the military, you would expect certain staff branches at every headquarters level. These include a Commander, usually a General or Brigadier, who commands the formation, and a Chief of Staff, who runs the day-to-day operations of the headquarters. The COS, or Chief of Staff, is divided into several branches, each responsible for different aspects of military operations. The G1 Branch handles personal matters such as manning, discipline, and personnel services, while the G2 Branch focuses on intelligence and security. The G3 Branch oversees operations, including staff duties, exercise planning, training, and combat development. The G4 Branch is responsible for logistics and quartering, and the G5 Branch handles civil and military cooperation. There are different levels of staff, including S staff for battalion and brigade levels, G staff for division and corps levels, J staff for joint operations between two or more services, and C staff for combined operations between two or more nations' militaries. A division is typically organized with a commander, who is a Major General, and three officers who report to him: the Assistant Division Commander for Operations, the Assistant Division Commander for Support, and the Chief of Staff. The Chief of Staff manages six officers, including G-1 for personnel, G-2 for intelligence, G-3 for operations, G-4 for logistics, G-5 for civil affairs, and G-6 for information systems. Each of these branches has its own responsibilities and areas of focus, and they work together to support the overall mission of the division.
